Customer and <<Company>> hereby agree as follows (incorporating the Schedule as a Term):

- 1. Development of Web Site/Digital Media.** <<Company>> agrees to develop the Web Site and other Digital Media as quoted and accepted by Customer. Services do not include any back-office, support, database or ASP services including multiplying the site across other domains or servers or creating new web sites or media based on the project components

- 2. Delivery of Web Site/Digital Media.** <<Company>> will carry out the services in a professional manner and shall use reasonable endeavors to deliver to Customer an operational Web Site according with the Project Description no later than the Commencement Date. Customer acknowledges, however, that this delivery deadline is an estimate, and is not required
- 3. Ownership Rights.** Customer shall own all rights in the Customer Content, which includes all text, graphics, animation, audio components, and digital components of the Web Site and Customer shall retain all of its intellectual property rights in any text, images or other components it owns and transmits to <<Company>> for use in the Web Site. <<Company>> shall own all right, title, and interest in and to the Web Site/Media including all interfaces, navigational devices, menus, menu structures or arrangements, icons, help and other operational instructions, and all other components of any source or object computer code that comprises the Web Site, all literal and non-literal expressions of ideas that operate, cause, create, direct, manipulate, access, or otherwise affect the Content and design elements. Customer shall not do anything that may infringe upon or in any way undermine <<Company>>' right, title, and interest in the Web Site, as described in this paragraph 3
- 4. Compensation.** For all of <<Company>>' services under this Agreement, Customer shall pay <<Company>> one half the Price at the date of this Order and the balance of the Price at the Commencement Date unless otherwise provided in Schedule and if not paid <<Company>> shall have the right, but not the obligation, to terminate this Agreement and remove the Web Site and/or Digital Media
- 5. Limited Warranty and Limitation on Damages.** <<Company>> warrants the Web Site will conform to the Site Description. If the Web Site does not conform to the Site Specification, <<Company>> shall be responsible to correct the Web Site without unreasonable delay, at <<Company>>'s sole expense and without charge to Customer, to bring the Web Site into conformance with the Site Description. Other than implied by law and not capable of being negated by agreement, this warranty shall be the exclusive warranty available to the Customer. Customer waives any other warranty, express or implied. Customer acknowledges that <<Company>> does not warrant that the

Web Site will work on all platforms. Customer acknowledges that <<Company>> is not responsible for
